YSAT - Youth Social Advocacy Team is a refugee youth-led non-profit organisation whose core mandate is to **support conflict affected youth** by tackling barriers to accessing quality education, sustainable Livelihoods and addressing root causes of violent conflicts to promote peace and self reliance for refugees and vulnerable host communities in Uganda using our own experiences as refugees.

YSAT has been legally registered to operate in Uganda with National Bureau for Non - Governmental Organizations Reg. **No.4743** as a regional NGO with thematic focus areas in: Community Based Protection, Food Security and Livelihoods, Education in Emergency, Environment & Energy, Evidence-based research and Advocacy spread across the districts of; Terego (Imvepi), Madi-Okollo (Rhinocamp), Adjumani with HQ based in West Nile, P.O. Box 661 Arua, Uganda.

Purpose

YSAT is seeking a competent Livelihoods and Economic Empowerment Officer for the Uganda Refugee Resilience Initiative (URRI), a 4.5-year project with funding from the Royal Danish Embassy to enhance climate resilience of women, men and youth in refugee and host communities and promote inclusive, cohesive, and environmentally sustainable development in refugee-affected areas in line with local priorities. URRI project will be implemented in Adjumani, Lamwo and Kyegegwa districts targeting both host communities 65% and refugees 35%. The project will be implemented in a Consortium led by Save the Children, World Vision Uganda, AVSI Foundation, Youth Social Advocacy Team (YSAT), Kabarole Research Centre (KRC), Uganda Network on Law Ethics and HIV/AIDS (UGANET) and Response Innovation Lab (U-RIL).

The project has 3 outcome areas: (i) Enhanced climate adaptation and resilience for women, men and youth in refugee and host communities through inclusive climate-smart agriculture, (ii) Sustainable management of the environment in refugee-affected areas through inclusive interventions leading to enhanced conservation of natural resources, biodiversity, ecosystem services, and productivity, and (iii) Enhanced gender equality and women's empowerment and rights among refugees and host communities in relation to agriculture, climate change adaptation and sustainable management of the environment. The **Livelihoods and Economic Empowerment** activities under URRI Project.

Duties & Responsibilities:

- Lead implementation of Livelihoods and climate smart agriculture activities including participants' identification, selection, profiling, mapping and verification process according to vulnerability criteria in collaboration with MEAL team
- Develop activity work plans and manage day-to-day activity implementation ensuring that
 project implementation is responsive to community needs, meets targets, and is carried out in
 line with best practices;
- Provide technical expertise and management of climate smart agriculture (CSA) approaches among targeted farmers and farmer groups.
- Provide relevant technical guidance and collaborate with the project Pre-Design team to design and deliver the participatory community assessments and co-create the project.
- Provides trainings to farmers and farmer groups on VSLA, financial literacy, bookkeeping, climate smart agricultural practices and market access.
- Engage and build strong relationships with community members, analyzing data collected to identify agricultural-related gaps, designing priority action plans and training modules on improved agricultural techniques and inputs in collaboration with MAAIF through the DLGs.

- Develop training manuals, content and deliver training for farmers, farmer groups, government partners, small and medium agribusinesses and other stakeholders on livelihoods and Climate Smart Agriculture
- Hire, orient and Supervise Community Based Extension Workers
- Create and sustain a work environment of mutual respect.
- Promote accountability, communicate expectations and provide constructive feedback via regular performance reviews of CBEW.
- Provide CBEW with information, tools & resources to improve performance.
- Contribute to Field Office team-building efforts, help members identify problem-solving
 options and ensure the integration of all CBEW into relevant decision-making processes.
- Identify any gaps or capacity needs for CBEW and ensure training and capacity building are incorporated into project planning.

Representation, Advocacy, Learning & Communication:

- Work with partners across the consortium to ensure coordination of activities with other stakeholders especially Adjumani DLG, Livelihoods & Protection partners, Office of the Prime Minister and UNHCR among others.
- Ensure that YSAT's work is coordinated with other agencies and Government, and support Interagency Coordination forums, advocating for the needs of conflict affected youth.
- Contribute to communications and media work as required through collection of data and information and sharing with the Consortium Lead
- Participate in stakeholder engagements during coordination meetings, workshops and other foras to enhance the project's impact and sustainability.
- Participate in quarterly review meetings to reflect on approaches, tools, impact of interventions, best practices, exit and sustainability strategies as well as create opportunities for action-learning.
- Create positive working relationships with Consortium partners, district local governments UN Agencies, Livelihoods and other stakeholders, up-to-date with current development trends.
